III. Duties

- Write unique and engaging speeches for clients based on information provided by clients. Speech information will be provided in writing or verbally from clients or project managers
- Coordinate and schedule phone consultations with clients, when applicable
- Hold phone consulations with clients to interview and gather speech information
- Provide professional speechwriting samples within two hours of receipt/assignment from the database and/or office, when assigned
- Use spell-check & grammar check from Microsoft Word to ensure quality of each speech
- Complete each assignment on time according to the United States Eastern Standard Time
- Provide immediate notification to administration if unavailable to fulfill an assignment. Request that this work be assigned to another speechwriter
- Give immediate notification if any project is uncomfortable, unfamiliar, confusing, or too difficult. Request that this work be reassigned to another speechwriter
- Provide professional communication via email or phone with clients as requested
- Fulfill our Satisfaction Guarantee whereby you will revise a speech if original instructions are not followed or information provided is not included
- Perform a minimal revision of up to three or four sentences if a client requests a revision
- Perform a more extensive revision if a client pays a rewrite fee

IV. Responsibilities

- 2. Payment of Taxes: The Independent Contractor will not be treated as an employee for state or federal tax purposes on the services rendered under this agreement. FirstEditing.com and all affiliated websites of Pro Writing & Editing Group, Inc. shall, to the extent it is legally required to do so, file all necessary tax information and reports (1099 within the USA) with the appropriate federal and state agencies, to report income of the Independent Contractor arising under this agreement. FirstEditing.com and all affiliated websites of Pro Writing & Editing Group, Inc. shall not withhold income taxes, social security taxes, disability insurance, unemployment insurance payments, or any other assessment or taxes from the earnings of the Independent Contractor unless required to do so by law notwithstanding the independent contractual relationship to the parties. b. The failure of the Independent Contractor to comply with any statute, law, or regulation applicable to their activities; or

c. Any private solicitation or personal communication with FirstEditing.com and affiliated websites of Pro Writing & Editing Group, Inc.'s clients.

- 4. Payment of Earnings: Payment of Independent Contractor's earnings will be paid MONTHLY by PayPal or electronic fund transfers (ACH) to US bank account. Payment will be transacted to the Independent Contractor on or before the first Monday of the following month.
- 5. Equipment issued: Online database and any other office tools provided by FirstEditing.com and all affiliated websites of Pro Writing & Editing Group, Inc. shall be returned immediately upon termination of the contract. The Independent Contractor shall independently provide all necessary and secure software, apps, hardware, malware, and internet connections.
- 6. <u>Cash Merchandise Responsibility</u>: Independent Contractor shall not handle monies on behalf of clients or company.
- 7. <u>Amendments</u>: The Agreement may only be amended in writing executed by both parties.
- 8. Governing Law: This Agreement shall be governed by and interpreted under the laws of the State of Florida (USA) in Orange County.

V. Non-Compete Clause:

- 1. Independent Contractor agrees not to work as a rival or competitor online or to work in competition for any rival or competitor online by providing any services related to editing or speechwriting companies.
- 2. Independent Contractor agrees not to form a new competing company as a competitor during the contract and within the one-year period following termination of Independent Contractor services with FirstEditing.com and all affiliated websites of Pro Writing & Editing Group, Inc.
- 3. Independent Contractor also acknowledges that during and within the one-year period following termination of Independent Contractor services their contact limitations. All contacts & exchange of information with any persons and organizations contacting, using, hiring, or enquiring about editing services are to be directed entirely to FirstEditing.com and all affiliated websites of Pro Writing & Editing Group, Inc. for future business procurement.
